1	All Candidates	SSC (Std. X) mark sheet, HSC (Std. XII) mark sheet, School Leaving certificate after passing HSC (Std. XII), Certificate of Indian Nationality of the candidate, CET- Score card.
2	Type - A candidates	Domicile certificate of Candidate indicating that he/ she is domicile in the state of Maharashtra. (In addition to the documents mentioned in Sr. No. 1)
2	Type - B candidates	Domicile certificate of Candidate or father/ mother of candidate indicating that he/ she is domicile in the state of Maharashtra. (In addition to the documents mentioned in Sr. No. 1)
3	Type - C candidates	Certificate from the employer in the Proforma - A stating that father/ mother of the candidate who is a central government/ Govt. of India undertaking employee and presently posted in Maharashtra. (In addition to the documents mentioned in S. N.1)

7	Physically Handicapped Candidates	Certificate in the pro forma - B/E1. (In addition to the documents mentioned in Sr. No. 1)
8	Candidates seeking for benefit of tuition fee waiver	Income certificate of Parents/ Guardians issued by the competent authority (Respective Tehasildar) of Govt. of Maharashtra stating that the income is less than Rs.2.5 Lacs for the year 2009-10
9	Candidates who are sons/daughters of Defence service personnel:	Certificate in the pro forma - D1/ D2/D3 as applicable. (In addition to the documents mentioned in Sr. No. 1 and as per the type of the candidate)
9	Foreign Nationals/ Foreign Students	Eligibility certificate from concerned University/ Proof of Foreign National or Foreign Student status as per definition in rule No. 1.2
10	Persons of Indian Origin	Eligibility certificate from concerned University/ Proof of Persons of Indian Origin status as per definition in rule No. 1.2
11	Workers in Gulf Countries/ Non Resident Indian	Eligibility certificate from concerned University/ Proof of Person working in Gulf Countries/ NRI Status as per definition in rule No. 1.2
12	NRI	Eligibility certificate from concerned university (if required)/ Proof of person having NRI Status as per definition in rule No. 1.2
